Professional career

1991 – 2004

Frankfurter Versicherungs-AG

Joachim started his career with an apprenticeship for insurance in September 1991. From November 1993 on, he acted as an advisor for private and business clients. In March 1998, he began his new position as Executive Assistant to the CEO. Joachim undertook the position as Head of Sales Area in January 2000 and after that as Head of Branch Office in January 2002. From January 2004 on, he acted as Head of Bancassurance.

2004 – 2008

Dresdner Bank AG

Joachim developed and implemented the business model for Bancassurance and Assurbanking between Allianz and Dresdner Bank from April 2004 to March 2006. From April 2006 to December 2008, Joachim acted as the Head of Sales for private and business clients in the Region Southwest Germany. From 2004 to 2008 he was a member of the Executive Committee.

2009 – 2010

Commerzbank AG

As a member of the Board of Management for private and business clients from January 2009 on, Joachim was responsible for Southern Germany (Baden-Wuerttemberg, Bavaria, Rhineland-Palatinate, Saarland, Hessen). Joachim also acted as a regular member of the Segment Credit Committee. In addition, he had program responsibility and participated in various integration projects with regards to the merger of Commerzbank and Dresdner Bank.

2010 – 2019

Allianz Beratungs- und Vertriebs-AG (ABV)

From July 2010, Joachim was a member of the Board of Management responsible for Strategy and Sales Management. From April 2014 on, Joachim was appointed as Chairman of the Board of Management (CEO). Amongst other activities, he led the turnaround of ABV with a transformation that delivered significant productivity increases leading to growth above market rates. From September 2014 to December 2016, he also was the Director of Labor Relations.

2014 – 2019

Allianz Versicherungs-AG

Joachim acted as member of the Board of Management for Sales from May 2014 until April 2016, when he was also appointed as Chairman of the Board of Management (CEO). During his time as CEO, he led the P&C segment to the highest GWP growth in over 15 years (4.0% in 2018) and to an above market growth for the first time in over 15 years.

Joachim was a member of the Board of Management with responsibility for Sales since April 2014 and a member of the Board of Management with responsibility for Property & Casualty since April 2016.
