Immediate priorities

- Arrange for cash before cover invoices to be issued pre-inception to ensure seamless coverage in transition
- Arranging for certificates to be issued as required (pre-allocation of premiums where required) to ensure continuation of local business activity
- Assignment of Multinational Program Manager, as well as pre-inception meeting arranged to agree deployment plan

Program information collation

Liaising with all internal and external stakeholders to ensure all information collated to implement program:

- Premium allocation, including checking exchange rates, collection protocols, tax, tariff and minimum premium standards are met
- Risk information including schedule of insured values and reinsurance slip
- Local client/broker contact information to ensure local policy issurance is not delayed

Network notification

Once information is collected, clear instructions sent immediately to our network via our digital Global Program System (GPS), creating clear audit trail


