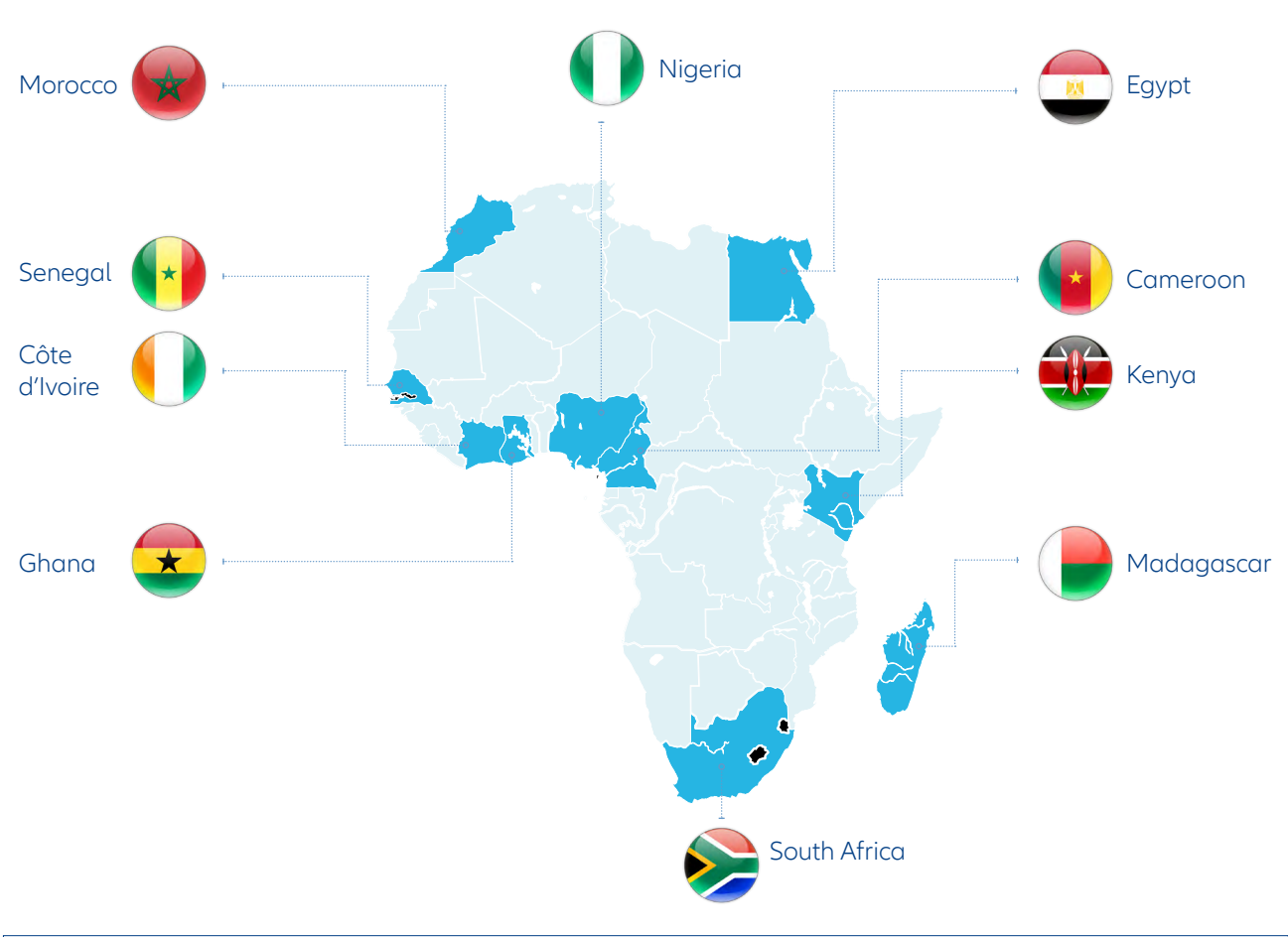

Allianz Risk Barometer 2023



The 12th **Allianz Risk Barometer** incorporates the views of **2 700+** respondents from **94** countries and territories. The annual corporate risk survey was conducted among Allianz customers (global businesses), brokers and industry trade organizations. It also surveyed risk consultants, underwriters, senior managers and claims experts in the corporate insurance segment of both AGCS and other Allianz entities
