

Cessation of Our Registration Status as VHIS Provider

Please note that effective from today (1 July 2022), we, Allianz Global Corporate & Specialty SE ("AGCS SE"), shall cease to be the Voluntary Health Insurance Scheme (VHIS) Provider (voided Registration No. 00030) following our application for de-registration to the Food and Health Bureau as approved accordingly.

Importantly if you are currently a policy holder of our VHIS Certified Plan (Certification Numbers S00030-01-000-02, F00033-01-000-02, F00033-01-001-001-002, F00033-02-001-02), your VHIS policy with AGCS SE shall continue in full effect. AGCS SE shall continue to:

- Renew your Certified Plan policy in accordance with Part 4 of the terms and benefits of your Certified Plan;
- Comply with the required practices stated in the Code of Practice for Insurance Companies under the Ambit of the Voluntary Health Insurance Scheme as issued by the Food and Health Bureau as far as your Certified Planpolicy is concerned; and
- Issue payment proof related to duly paid premiums under your Certified Plan policy to assistyou in claiming VHIS tax deduction.

- 就您的認可產品保單,我們會繼續發出保費付款證明以協助您申請自願醫保計劃稅項扣減。
