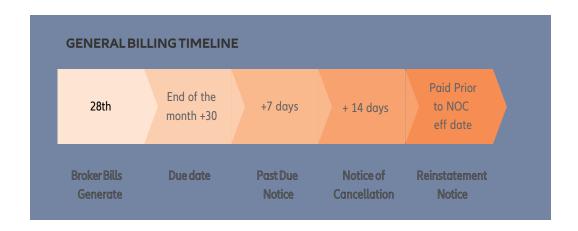

- 4 Pay Four equal installments due on X, X+75, X+150 and X+240
- 10 Pay 1st Installment is 25% of premium, 2nd 9th Installment are 8.33% of premium, and 10th installment is 8.36% of premium and are due on X, X+30, X+60, X+90, X+120, X+150, X+180, X+210, and X+240
