WHAT IS A TOP-UP (VVG) POLICY AND WHO NEEDS IT?

VVG cover, also known as a top-up and supplemental policy in Switzerland, provides an additional level of cover to the local Swiss mandatory health insurance (KVG/LAMal). The VVG policy offers insured members the freedom to choose their preferred medical provider in Switzerland or abroad.**

WHO ADMINISTERS MY BASIC (KVG) POLICY?

Your local KVG/LAMal insurer looks after treatments inside of Switzerland, up to the limits of your KVG/LAMal cover.

WHO ADMINISTERS MY TOP-UP (VVG) POLICY?

Allianz Care looks after the on-boarding and invoicing as well as claims processing, case management and general query handling for your treatments outside of Switzerland and when you have opted to receive private or semi-private hospitalisation in Switzerland.

WHO IS MY POINT OF CONTACT?

Allianz Care for queries regarding treatment outside of Switzerland and your local KVG insurer for queries regarding treatment inside Switzerland.

HOW CAN I ACCESS TREATMENT?

Inside Switzerland

Your local health insurance (KVG) provider is your first point of contact if you require a treatment inside Switzerland. You should contact Allianz Care only once the cover under your mandatory (KVG) policy has been exhausted and you need to avail of your top-up (VVG).***

Outside Switzerland

The Allianz Membership Card provides you access to treatments and a comprehensive international network of healthcare providers outside of Switzerland. If your treatment requires pre-approval, download a Treatment Guarantee Form from our website, complete it and send it to us at least 5 days before the planned in-patient treatment.

Out-patient and day-care claims for treatments outside of Switzerland can be submitted on a "pay and claim" basis via our award winning Allianz MyHealth Digital Services.
